The performance criteria for 2016 were met, resulting in vesting of 1,250 shares. This report is being filed to reflect the vesting of these shares.
- On February 24, 2015, the reporting person was granted 5,675 shares of restricted Common Stock that were issued pursuant to the Retail Opportunity Investments Corp. 2009 Equity Incentive Plan. The shares vest as to 1,892 shares on January 1, 2016, 1,892 shares on January 1, 2017 and 1,891 shares on January 1, 2018 based on the Issuer's achievement of certain performance criteria for each of the 12 months ending December 31, 2015, 2016 and 2017. The performance criteria for 2016 were met, resulting in vesting of 1,892 shares. This report is being filed to reflect the vesting of these shares.
